MARKS GRAY WINS A DEFENSE VERDICT FOR THE CITY OF LAKE CITY

JACKSONVILLE, Fla, Tuesday, September 26, 2017: Marks Gray, P.A. is pleased to announce Attorneys Tyler J. Oldenburg and Meagan L. Logan, successfully defended their client, the City of Lake City, and received a winning defense verdict.

The Plaintiff, America's CNG, LLC, alleged that the City of Lake City was in breach of a contract that required the City to sell it natural gas for a period of ten years. The Plaintiff argued that the City refused to sell it natural gas or to comply with its obligations under the contract. As a result of the alleged breach, the Plaintiff claimed it had incurred over \$12,500,000.00 in damages. Mr. Oldenburg and Ms. Logan defended the case on the grounds that there was not a valid contract (due to the omission of a signed non-compete provision), the Plaintiff failed to perform (or was not able to perform) its obligations under the contract, and that the Plaintiff did not sustain any damages as a result of the City's conduct. At the conclusion of a nine-day jury trial in Lake City, Florida, the jury returned a defense verdict.
