The Florida Legislative Session Ends Without an Immigration Bill

As referenced in our April 2011 update, the Florida Legislature had been working on bills that would require all employers in Florida to verify their employees' work eligibility status with the federal program known as E-Verify. However, the House and Senate lawmakers ended a 60-day session without coming to an agreement

Georgia Takes on More Immigration Regulation



Georgia lawmakers have passed an immigration bill that would allow law enforcement to request information about suspects' immigration status; requires private employers (those with more than 10 employees) to use E-Verify; and places new burdens

Issuance of "No-Match" Letters Resumed

The Social Security Administration (SSA) announced that it will resume sending "No-Match" letters to individuals and employers. These letters are issued when there are discrepancies between the information reported on form W-2 and the SSA records. SSA stopped sending these letters in 2007 when regulation was being considered providing a 'safe-harbor' process for employers to follow upon receipt of a nomatch letter.

The challenge now becomes whether receipt of a no-match letter gives the employer "constructive knowledge" that the employee is not authorized to work. Click here for some guidance on the letters for employees and employers from the Department of Justice.
